IT IS HEREBY ORDERED, that until further Order of this Court:

Defendant Project Management Technical Institute, LLC, its agents, employees, affiliates, and subsidiaries, are hereby immediately enjoined from any and all ~~further~~ use of "PMTI" and "Project Management Training Institute" in any manner whatsoever, including but not limited to, and by way of illustration only:

- a. Using them on their websites;
- b. Using them connection with any kind of advertising promotion and/or marketing, of their goods/services whether oral or written through any media, including the internet;
- c. Using them in connection with any communications through any media;
- d. Using them in connection with registering individuals, business, other organizations, and/or governmental units for attendance of project management courses;
- e. Using them in any way that causes their websites to be linked to any internet search results for "Project Management Training Institute" and/or "PMTI";
- f. Using them to identify their business and/or the goods and services they provide;
- g. Using them in any email address, whether or not other letters, numerals, words, or symbols are included in the email address;
- h. Embedding either "PMTI," or "Project Management Training Institute" on any of its websites and/or web pages; and

Until further Order of this Court WM FCK EG

IT IS FURTHER ORDERED that ^v Defendant Project Management Technical Institute, LLC, its agents, employees, affiliates, and subsidiaries is hereby immediately enjoined from conducting any further business under ~~the~~ ^{the} "Project Management Technical Institute" name that competes with Plaintiff, including but not limited to, and by way of illustration only, it is enjoined from:

- a. Offering for sale project management training courses;
- b. Selling project management training courses;
- c. Accepting any kind of consideration in return for providing project management training courses;
- d. Accepting any kind of consideration in return for referring individuals, businesses, other organizations, and/or governmental units to any provider of project management courses, including but not limited to the provider Defendant Proxalt, LLC;
- e. Maintaining a website that advertises the sale of or discusses or references project management training courses;
- f. Engaging in any kind of advertisement, marketing, and promotional activity, including maintaining a website, that discusses and/or references project management training courses or companies that offer or advertise or promote project management training courses;
- g. Soliciting anyone, including individuals, businesses, other organizations, and governmental units for purposes of offering and/or selling project management training courses, either on behalf of itself or on behalf of any other provider of project management courses, including but not limited to on behalf of Proxalt, LLC;
- h. Conducting any further business whatsoever with Defendant Proxalt, LLC;
- i. Linking any of its webpages to any of Proxalt LLC's webpages;
- j. Linking any of Proxalt LLC's webpages to any of its own webpages;
- k. Linking its website to any other website that offers for sale or advertises project management training courses; and further .
- l. Embedding either "PMTI," or "Project Management Training Institute" on any of its websites and/or web pages; and

- m. Using or referencing "PMTI," "Project Management Training Institute," and Proxalt, LLC in any of its marketing, advertising, and promotional efforts, or any other communications, whether orally or written in any kind of media including its website.

- a. Using 4pmpti in any email address in connection with offering, soliciting, and/or selling project management training courses, including for purposes of communicating with individuals, businesses, and other organizations, and governmental units or agencies, regarding or in connection with and/or for purposes of discussing project management training courses and related information;
- b. Creating and/or maintaining, causing, requesting, or giving consideration for any non-party to maintain and/or create a website with 4pmpti in the web address, URL and/or any web page, which website is for the purpose of advertising, offering for sale, discussing, or promoting project management training courses and/or registering prospects for such courses and/or referring prospects to providers of such courses, including but not limited to Proxalt, LLC; and
- c. Creating and/or maintaining, causing, requesting, or giving consideration for any non-party to maintain and/or create a website with 4pmpti in the web address, URL and/or any web page, which website is linked to any of Proxalt LLC's web pages and/or any of Project Management Technical Institute LLC's web pages.


